Maureen	Charter Amendment	Presented a proposal that staff submitted for an amendment to the charter. The proposal for the amendment states: Any expenditure, purchase or long –term obligation, in excess of \$500,000: • Must be ratified by two-thirds vote of Mueller Charter School staff (one organization) under the same voting conditions as referenced in Element Four, "Amending the Charter." • This applies to purchases, obligations, or investments either proposed and/or approved by either Leadership Council or the Charter Board. • Authorization to proceed with any encumbrance as referenced above, without ratification of two thirds of the staff will be invalid. LC approved. LC also approved the following timeline: First Meeting: Wednesday, September 9 @ 7:15 Second Meeting: Thursday, September 10 @ 3:45 Voting: Friday, September 11	The Charter states, "All staff will be invited to submit proposed amendments to the Charter Petition; • The Leadership Council will review all proposed changes to the petition and will assess each proposal on the basis of consistency with charter goals, needs of children, and applicable laws and policies; • Leadership Council will establish a timeline for voting process; • A series of staff workshops will be held for open discussion, debate and revisions"	Staff	Follow timeline
